President's Foreword

Aneeka Muneer Sarwar: Review of the Presidential Year 2024

It seems remarkable that the end of my Presidential Term has drawn to a close. My journey through LLG has taught me so much about the complex landscape we navigate and the strength and resilience of local government lawyers and governance officers.

The role we play within local government is critical to the rule of law, equitable governance and the success of our authorities. LLG have pushed through an agenda this year which continues to influence at the highest level to demonstrate the value we bring to our communities and the importance of our role in the effective operation of our councils. I reflect on some of our achievements to this aim as follows: -

Spring Conference 2024

For me, the Spring Conference 2024 was a beacon of inspiration, emphasizing the importance of contributing to society and addressing inequalities within communities and political power structures. The conference highlighted the significance of speaking truth to power and symbolised the ongoing fight for justice. As lawyers, the commitment to upholding the rule of law was underscored as integral to this fight.

The conference introduced the LLG, CIPFA and SOLACE Code of Practice on Good Governance for Statutory Officers in Local Government, a positive step towards building robust organisations. Lawyers were highlighted as crucial in understanding organisational culture and decision-making processes. The Code's reflection on the dynamics of statutory roles and the concept of the 'golden triangle' was particularly noteworthy.

The conference also welcomed the SRA guidance for in-house lawyers, recognising the unique roles and ethical conflicts they face. This guidance was seen as a significant step towards acknowledging and supporting the legal profession's diverse challenges.

Governance Conference 2024: Good Governance for All



In December, I reflected on the year's focus on good governance and representation. The unexpected passing of Suki Binjal, a champion for diversity and social mobility, was a poignant moment. A JustGiving page was set up in her honour, raising £6,600 to continue her work supporting junior lawyers.

I emphasised the importance of good governance, leadership, and accountability in fostering trust within communities and contributing to local development. Representation at the leadership level was highlighted as essential for addressing inequalities and ensuring thriving communities.

I spoke on resilience in governance, defined as the ability to anticipate, prepare for, respond to, and adapt to adverse events while maintaining essential services and thriving long-term. Resilience was emphasised at individual, service, and council levels, enabling organisations to embrace change effectively.

Islamophobia Panel

I also Chaired the Islamophobia Panel which provided a platform for practical discussions on the impact of Islamophobia in workplaces and communities. The panel addressed the shift from overt racism to microaggressions and the recent riots that highlighted societal divisions and questioned the sense of belonging for many.

Baroness Warsi

Baroness Warsi, a tireless advocate for equality and representation, was introduced by me as a keynote speaker. Her work on Islamophobia and her call for systemic change in political leadership, media representation, and accountability for hate speech were particularly inspiring.

LLG Awards 2024

I was honoured to present the Significant Contribution to Local Government Law and Practice Award to Dorren Forrester-Brown. This award recognised her lifetime commitment to local government law and practice; her advocacy for the sector, and her efforts in promoting diversity and inclusion. Her leadership and groundbreaking approaches have significantly shaped and advanced local government practices.

Conclusion

My Presidential Year 2024 was marked by a strong commitment to justice, good governance, resilience, and representation. The events and initiatives throughout the year underscored the importance of addressing inequalities, supporting the legal profession, and fostering a culture of accountability and inclusion.



Chief Executive's Comments

CEO's Review of the Year: April 2024 to April 2025

I'm pleased to say it's been a strong year for delivery, engagement, visibility and influence within LLG on several important fronts:

Code of Practice on Good Governance for Statutory Officers

The Code of Practice on Good Governance, released on 16th July 2024, represents a significant collaboration between LLG, CIPFA, and SOLACE, with assistance from Phil McCourt at Bevan Brittan, who assisted in authoring the practical guide to working in the golden triangle. This document will provide a strong, unambiguous guide for all Monitoring Officers in the delivery of their role and responsibilities.

Government Consultation on Remote Meeting Provision

After years of lobbying and campaigning tirelessly, the sector received exciting news from the government (at the LGA conference) that they were moving towards allowing local government to make decisions in remote and hybrid meetings. We consulted our members via roundtables, surveys, a working group, engaged with the LGA, NALC, SLCC, and ADSO and secured helpful input from Welsh members into our consultation response. We also teamed up with Transport for the North to make bespoke representations to the Minister.

Strengthening Standards and Conduct Framework

Consultations came thick and fast, with the government launching in December 2024 a consultation on "Strengthening the standards and conduct framework for local authorities in England." We once more gathered input for our response via National Leads, regional meetings, the LGA taskforce, and a member survey. Prior to the consultation closing we attended a Ministerial roundtable with Jim McMahon and a high-level seminar on standards hosted by the Committee for Standards in Public Life.

Other consultations LLG has responded to include the Planning Reform Working Paper - Planning Committees (February 2025) and work is ongoing with respect to the Oversight and



regulation of private prosecutors in the criminal justice system consultation (Due 8th May 2025).

Local Government Reorganisation and Devolution

Again, the government sprang to life and were active in this area, moving at speed. The LGA pulled together a group of key stakeholders including LLG to provide support to members going through the process. hour. We've also been in conversations with SLCC about the changing landscape for parish councils within reorganisation and devolution and have developed training to inform members in this important area.

But it's not just about external influence, LLG has worked hard to provide member services 2nd to none this is particularly pertinent in development and training opportunities:

LLG Inspire Programme

Our very first inspired programme closed at the end of the year, with a positive feedback session that led to further improvements in the offer in line with our philosophy of continuous improvement. The 2024 Inspire Programme launched last September with 35 lively and enthusiastic delegates, welcoming a number of Democratic Services Officers to the programme for the first time. Recognising the importance of developing statutory officers, the Ministry of Housing, Communities and Local Government provided bursary funding. We produced the 'Essential competencies and Expectations of a Monitoring Officer,' aligning with the competencies for the s151 officer and the Chief Executive.

We kicked off 2025 with an in-person day for our Inspire delegates, along with delegates from CIPFA and SOLACE. The focus was on the Code of Practice on Good Governance for Statutory Officers, diving into real-life issues and practical solutions within actual golden triangles.

Conferences:

Members were offered a wide range of one day conferences including our first-ever Children's Services and Education Conference (a huge success that is sure to be repeated).

The Spring Conference at Leeds in June was a highlight of the LLG calendar, with significant engagement and debate. The LLG Awards ceremony recognized the contributions of lawyers and their teams across the country. It was personal, fun, emotional, and entertaining—a good time was had by all.

Our hybrid Monitoring Officer conference attracted the highest ever number of attendees, with in-person participants making the most of networking opportunities.

Continuing the idea of developing our lawyers to be the legal leaders of the future: the Leadership Conference in March 2025 was a success with a strong programme that encouraged thinking and reflection.

Our December 2024 Governance Conference had a new one-day, multi-programme format at Trowers & Hamlin's. It was extremely well attended and received rave reviews.



Consultancy

LLG's consultancy offering has gone from strength to strength, and we have worked over the last year with a significant number of councils and stakeholders in the sector with respect to reviews of legal services and democratic services departments, The procurement of legal work, governance reviews, preparation of guidance documents, investigation of complaints and whistle blowing allegations, the building of panels, and preparation of in-house training material.

Work Experience Week

Work Experience Week took place during election week, accommodating nearly 40 students despite cancellations due to the general election. It was a tremendous success with a great programme and promising interns, some of whom have already secured jobs. We were finalists in the ISE awards for our Work Experience Week. Although we didn't win, it was impressive to be shortlisted alongside big names such as Lloyds Bank.

The Professional Body for Monitoring Officers:

LLG has a strategic aim to deliver a professional body for monitoring officers by the end of 2025. During 2024, significant work has been done on developing the strategy, makeup of the membership, and deliverables. As part of this work, a number of discussions and roundtables have taken place, including a lively session in March at Browne Jacobson's offices around the important work on the Role & Responsibilities of the Monitoring Officer, which highlighted the need for increased support and networking and helped us understand the services the professional body should provide.

Strategic and Governance Review

Internally, LLG has taken time to check it is fit for purpose and undertook both a Governance Review and a Strategic Review. Several recommendations from the Governance review are to be implemented, not least the proposal to appoint an independent Chair of the board of LLG to reduce the burden on the President, bring in an experienced Chair which should give stability on chairing to board meetings as the appointment will be for a longer term, thus allowing the President to focus on their ambitions for LLG and their areas of interest. The main outcome of the strategic review was a focus on developing clarity on the Professional Body for Monitoring Officers which will be a key deliverable over the next period. One to watch!

So, a huge thank you from me to the members for their support and engagement over the last period, and we look forward to working with you on the many and various challenges for the sector that lie ahead!

Testament to Suki Binjal



It was with absolute heartbreak that LLG learnt of the news of the untimely and sudden passing of Suki Binjal who passed away on 4th October 2025. A former LLG President, Suki was instrumental in shaping the company as it now stands and a prominent figure in local government law and practice. Beyond all that however- she was a valued and close colleague.



Suki was the epitome of joyous revelry- the sage pioneer for equalities; a mentor, a zealous and passionate promoter of local government- but above all of this, she was a great friend. We thank all our members for the support they have shown for each other and to those affected by the loss of Suki. She herself believed fiercely in the family of lawyers in local government. We honour Suki each time we safeguard our unity and acknowledge our strength together.

To honour Suki, a fund has been set up to offer support to junior lawyers and aspiring leaders working in the local government legal world. LLG have also dedicated an award to Suki entitled the "Suki Binjal Rising Star Award" which will see its first recipient at the LLG Awards 2025 in June.

LLG Regional Director Reflections and National Lead Reflections: -

Regional Director - Wales update



We held a successful remote regional meeting in June 2024, where training was provided by Civitas Chambers, to housing colleagues on the Renting Homes (Wales) Act 2016 and the implications to local authority landlords. In November 2024 our Junior lawyer lead, Samuel Pitchford, hosted an in-person training event at The Law Society offices in Cardiff, which was well attended, and positive feedback was received. We held a further meeting in January 2025 where one of our corporate partners, Weightmans provided training on the new Procurement Act 2024 and the specific implications in relation to the law in Wales.

We also launched a revised Welsh Bulletin providing bespoke updates pertinent to the Welsh jurisdiction. This was taken over by Bulletin Editor, Dennis Hall following the departure of Janet Hooper who had undertaking provision for many years. Our thanks to Janet for her service to the Welsh members.

Looking forward, this year, I intend on focusing my attention on re-establishing the shared interest groups across the region and recruiting regional leads to assist in driving this forward this initiative.

Regional Director - London Update





Members from the London Region had a very engaging session on 5 September 2025 where we were hosted by Capsticks. Nicola Birkett and her colleagues', Mary Mundy, Partner and Anita Rao, Principal Associate, provided excellent training on the Procurement Act 2023 to enable authorities to prepare for the implementation of the new arrangements. Having not met as a group since before Covid, members enjoyed seeing old and new colleagues. With three elections last year, it has been a busy period, but members have agreed to collaborate more frequently in person in addition to ongoing one on one discussions between colleagues. Regional Director - Southern Update



The Southern Regional Meeting held on 24 September 2024 and I was delighted to provide the welcome with training provision from Anthony Collins, followed by a Q&A session. The guest speaker, Max Howarth from Anthony Collins, presented on the planning changes from the Government and its effects on Local Government.

I was pleased to be invited to open the LLG Southern Region's Partnerships & Procurement Group Meeting on 13 February 2025. The event was informative and timely with the Procurement Act 2023 coming into force on 24 February 2025. Upcoming training events for Monitoring Officers were highlighted, including the Local Government Golden Triangle



Development Day on 25 March 2025, and an exclusive session for LLG Member Monitoring Officers on 17 March 2025.

On 12 March 2025, Darren Hooker from Capsticks delivered a presentation on regulatory inspections for local authorities, covering the Social Housing Regulation Act 2023 and its implications. Key changes include the introduction of new consumer standards, removal of the "serious detriment" test, and enhanced powers for the Regulator of Social Housing. The presentation also discussed the grading system for local authorities and common themes in gradings, such as gaps in health and safety compliance and significant backlogs of repairs. Recommendations for local authorities to improve compliance, tenant engagement, and data quality.

I am currently working on the plan for the Southern Region events and meetings for the rest of 2025/2026 to ensure improved organisation and early communication with members. An in-person event in the Southern Region is proposed and Members' thoughts on this would be very welcome.

We launched the Code of Practice on Good Governance for Local Authority Statutory Officers in July 2024, and I was invited to raise awareness of it at a closed session for Monitoring Officers, section 151 Officers and Chief Executives at the LGA Conference in October.

I represented LLG on a working group with Cipfa and Solace on a draft Addendum to Cipfa's Delivering Good Governance in Local Government Framework. The Addendum, which was consulted on in the early part of this year, provides guidance on the preparation of Annual Governance Statements and Local Codes of Corporate Governance. I am also LLG's representative on the LGA's Monitoring Officer Sounding Board, which seeks to support the development and improvement of local authority governance.

I have represented LLG at discussions on the Strengthening the Standards and Conduct Framework for local authorities with the LGA and the Committee in Standards in Public Life. Paul Turner also joined a roundtable discussion with DCLG on the same topic.

The Monitoring Officers Conference in September provided a good opportunity for us to strengthen our links with the Local Government and Social Care Ombudsman and improve communication between our organisations. We have started to progress the establishment of a professional body for Monitoring Officers, informed by feedback from the membership at the Monitoring Officers Conference and our periodic coffee catch ups. I look forward to continuing this work in the coming year.

Monitoring Officer Induction Programme



The Monitoring Officer Induction Programme is a comprehensive and tailored programme for new Monitoring Officers and Deputy Monitoring Officers. Traditionally the guardian of good governance, lawful decision making, and high standards of conduct, the Monitoring Officer is increasingly required to cultivate additional skills in an ever-more complex political and financial landscape.

LLG's Monitoring Officer Induction Programme is tailored specifically to the needs of MOs and DMOs and comprises a comprehensive blend of live and pre-recorded training sessions to prepare them for this challenging role. The Programme has been designed to provide new MOs and DMOs with a thorough grounding in the fundamental elements of the role of the Monitoring Officer, as well as detailed, practical training on some of the key areas of focus for MOs including governance, finance, scrutiny, working with Independent Persons, political awareness and dealing with Members.

LLG Training has seen three cohorts of this Programme run successfully since September 2024, with a great demand for places.

Cohort 1 – 05 September 2024

The very first Monitoring Officer Induction Programme consisted of 14 modules and a total of 18 delegates booked on. This ran until 31 December 2024.

Cohort 2 – 01 November 2024 – 14 modules

Due to popular demand, we ran the Programme again shortly after the commencement of the first Programme. This ran into the new year and until 31 January 2025, with a total of 20 delegates. This also consisted of 14 modules.

- Cohort 3 - 01 February 2025 - 14 modules

Running until 31 April 2025, the third Programme took place at the beginning of February. Yet again, this Programme was fully booked with 20 delegates and consisted of 14 modules.

- Cohort 4 - to commence 10 June 2025 - 13 modules

So far, we have 9 delegates booked on for the next Programme set to commence in June. We took the decision to retract the "Delegate Choice" module, thus totalling 13 modules.











In November 2024, LLG introduced enhanced tracking across key areas, including delegate numbers, course feedback, financials, engagement, and more. The results so far:


