We live in an age if internet fuelled suspicion and conspiracy. Never has the Public been able to see the inner workings of Government all levels like they can today. This means that policy, decision-making and service delivery must be based on sound principles and good governance. They must be open and defensible.

The trend for public lobbying to produce Inquiries, Inquests and Investigations means that officials have more than Judicial Review to fear of they get it wrong. Hardest of all is the "Court of Public Opinion", in which the worst crime is the cover-up.

Our session will examine how recent Inquiries and investigations reveal failures of governance, and the traps that await officials. We will take delegates through the lessons of past mistakes and equip them to avoid the same outcomes.

2) The Ethical Use of Al in Public Services

The ethical use of AI in public services is now a central governance priority. As councils adopt AI to improve service delivery, decision-making and productivity, they face a set of risks that demand clear frameworks, proactive oversight and strong organisational leadership.

Five domains are critical. Data protection requires lawful bases, meaningful DPIAs, and assurance that systems use only the minimum personal data necessary. Bias and discrimination risks must be addressed through auditing datasets, stress-testing models, and monitoring outcomes across protected characteristics. Transparency and explainability are essential so that residents can understand, question and challenge decisions that affect their lives. Cybersecurity becomes more complex with AI systems, which can be vulnerable to adversarial attacks, data poisoning and model manipulation. Procurement and contracting must evolve to include requirements around fairness, auditability, transparency, and robust security obligations.

A risk-based, principles-driven governance approach is essential. Public bodies should establish Al inventories, classify systems by risk level, embed human oversight, and ensure that decision pathways remain contestable. Training is vital to reduce "automation bias" and support responsible human-machine collaboration.

Ethical AI is not simply a technical project. It is a whole-organisation capability, rooted in governance, accountability and public trust.

10.00 - 11.00 Public Authority (Accountability) Bill

This session explores the Public Authority (Accountability) Bill—often called the "Hillsborough Law"—and its far-reaching implications for local authorities, including both councillors and officers, and their legal teams.

The session will provide a practical analysis of the Bill's key provisions, including the new statutory duty of candour, enhanced ethical standards, and the introduction of personal criminal liability for failure to comply, together with other criminal offences for serious misconduct in public office. Attendees will gain insight into how the Bill aims to reshape governance, transparency, and accountability in the public sector, with a particular focus on the responsibilities of local authority lawyers. The session will also address the Bill's impact on inquests and public inquiries, highlighting measures to ensure fairness for bereaved families and proportionality in legal representation.
