## 12.30 – 13.15 Gang Based Child Sexual Exploitation & Abuse

It is nearly 11 years since Alexis Jay published her report on sexual exploitation in Rotherham. It first brought the issue to public attention and led to sweeping changes to that Council. However, the grooming of teenage girls is not a new phenomenon and not limited to Northern towns, but Jay gave it a name – "Child Sexual Exploitation" or CSE. It is a manifestation of a specific type of paedophile activity.

Since Rotherham, there have been dozens of Local Authority investigations, Case Reviews, and a local Inquiry in Telford. All of them have provided a detailed examination of the local picture on CSE. Never have there been a National Investigation looking at all places, all agencies and joining the dots. That is what a National Inquiry can do – and now we have one. Based on the current crop of statutory Inquiries, the question is whether it will deliver that?

This session will examine the roots of the Inquiry, what we know about it so far, what organisations it will examine, and how best to respond if it decides to look at your Council. Stepping back from the headlines, CSE is an extremely serious crime that blights lives. This Inquiry could make a real difference and engaging well with it is the key.
