



How to book a conference

YOU WILL BE NOTIFIED

As soon as each conference is announced we will email you with all of the conference details for you to make your booking.

DISCOUNT CODE

You will be supplied with a discount code to apply at the booking confirmation page

BOOKING PROSESS

Log onto the website www.llg.org.uk. Click on the Training tab to see the full list of courses and conferences and select the conference you would like to book. View the conference details and then click the book now button. In the table of ticket options, select 1 individual ticket. This will show the full price until you enter your discount code. Your details will automatically be entered on the booking form and you must ensure the 'member' box is ticked. Click next to confirm & pay. Here you will add your discount code in the voucher code box. Click apply. The total above will now show as £0.00. Tick to confirm the T's & C's then choose to pay by invoice. The system will produce an invoice but it will have a £0.00 value. Fill in your details and then click pay by invoice. Your booking is now made. A booking confirmation email will be sent to you and your booking will be listed in the My LLG tab for you on the website.
